

On the subject cited above it is pertain to mention here that

- 1 All J&K Patwar Association is a registered organization recognized vide Govt Order No: 394 GAD of 1999 dated 19-03-99 .
- 2 AJKPA is requesting for the last One year for the early release of salaries of patwaris especially appointed through BOPEE.
- 3 That after the completion of one and a half year yet the Service Books of these Patwaris are not maintained, even the service Books of Senior Patwaris and Girdawars are not completed till date.
- 4 That the patwaris appointed through BOPEE in all the Tehsils of District Jammu are working without salary for the last one and a half year.
- 5 That besides our again and again request to the concerned quarters nobody is bothering for the cause.
- 6 That from the date of appointment of BOPEE Patwaris they have transferred from one tehsil to other but the service book and LPC yet not submitted to the concern, even these are not prepared. It is further submitted that even the Service Book of Senior Patwaris and GQs are not completed.
